- 5. And whereas, the Government in the reference tenth read above orders were issued constituting the Unified Metropolitan Transport Authority for Hyderabad Metropolitan Region with the following Members as specified in sub-section (1) of section-16 thereof in exercise of the powers conferred by sub-section (1) of Section 16 of Hyderabad Metropolitan Development Authority Act, 2008 (Andhra Pradesh Act No.8 of 2008).

And whereas, the Government in the reference eleventh read above orders were issued nominating Head of the Department of Transportation Division of National Institute of Technology, Warangal (which is one of the Centre of Excellency in the field of Traffic & Transportation in the country) and Sri P.Radha Krishna Murthy, Chief, Transport and Communication Division, Mumbai Metropolitan Region Development Authority, Mumbai as Members of Unified Metropolitan Transport Authority (UMTA).
- 7. And whereas, the Metropolitan Commissioner, Hyderabad Metropolitan Development Authority, Hyderabad in the reference twelfth read above has reported that as per the provisions of the G.O.Ms.No.624, MA&UD Department, dated 08.09.2008, on the constitution of UMTA for HMDA, item XIII of para (6), the Government can nominate any person as a member, as been done earlier vide G.O.Ms.No.454 MA&UD Department, dated 19.10.2010 for nominating Managing Director, Hyderabad Metro Rail Limited. Further, he has stated that in the 8th Meeting of UMTA held on 04.04.2013 in item No.14, it has been resolved that "since many issues were related to Finance Department, the Chairman suggested to include the Principal Secretary Finance as a member of UMTA". Hence, it was resolved to include the Principal Secretary Finance as the Member of UMTA. Therefore, he has requested to nominate Principal Secretary, Finance as a Member of UMTA as resolved in the meeting and issue necessary orders in this regard.
- 7. Now, the Government after careful examination of the proposals submitted by the Metropolitan Commissioner, Hyderabad Metropolitan Development Authority and as recommended by him vide reference twelve read above, decided to appoint and nominate the Principal Secretary to Government, Finance Department as Member of Unified Metropolitan Transport Authority (UMTA).
