1. That in pursuance of the Land Acquisition Proceedings, a general Award No. \_\_\_\_\_ was passed on \_\_\_\_\_ in which I am/we are one of the claimants. Accordingly, I/we requested the HMDA to award 1000 Sq. Yards developed land for every one acre of land acquired instead of monetary compensation. Upon the proposals submitted to the Government, the Government accepted the same and issued G.O. Ms No. 36 dated 22-01-2011 permitting HMDA to award/allot 1000 Sq. Yards developed land for every one acre land acquired as compensation. I have been awarded \_\_\_\_\_ Sq. Yards land as compensation as per the said G.O. in lieu of acquisition of my lands acquired in Sy. No. \_\_\_\_\_ extent Acs. \_\_\_\_\_ gts. Of Uppal Bhagat Village, Uppal Mandal, Ranga Reddy District (now Medchal District) for the purpose of Musi River Conservation and River Front Development.

2. Subsequent to passing of the general award, myself and HMDA have entered into an agreement/ compromise in respect of my claim towards my land on \_\_\_\_\_. In pursuance of the said agreement/compromise, myself and HMDA referred the matter to Lok Adalat in P.L.C. No. \_\_\_\_\_ / Collector

award No. \_\_\_\_\_. The said reference before the Lok Adalat / Collector has been adjudicated and I have also accepted the same as per the compromise petition before the Lok Adalat / Collector. Accordingly, the Hon'ble Lok Adalat / Collector passed an award and the same is on record.

3. That I hereby also endorse and assert that before the Lok Adalat / Collector, I have given my consent to pass award in terms of compromise and the same is awarded. Therefore, I did not prosecute any legal proceedings against HMDA before any Authority, Tribunal, Court including the Constitutional Courts.

4. That in pursuance of the Award dated \_\_\_\_\_ in P.L.C. No. / Collector \_\_\_\_\_ passed by the Lok Adalat / Collector, I have delivered possession of my property in favour of HMDA to facilitate the HMDA to develop the land and demarcate the plots. Accordingly, HMDA has developed the plots and earmarked the roads, drainage and the individual plots.

5. That I read the said G.O.Ms No. 36, dated 22-01-2011 in respect of concessions and also compensation towards acquisition of my land and the procedure, guidelines to be adopted by the HMDA in allotment of the plots and its extent of land. I voluntarily undertake to abide by procedure, guidelines and proceedings taken by HMDA in allotting the plot(s) in my favour in pursuance of my claim under Award No. /PLC No. \_\_\_\_\_ / Collector award no. \_\_\_\_\_ dated \_\_\_\_\_.

6. That I further state and undertake and also hereby declare that :-

Select the extent rounded off to the higher multiple of 50 i.e. \_\_\_\_\_ Sq. Yards. For this, I declare that I am willing to buy the extra extent of \_\_\_\_\_ Sq. Yards (not more than 49 Sq. Yards) of land added as per the above procedure, by remitting the amount calculated for that extent at the rate fixed by the HMDA for this purpose.

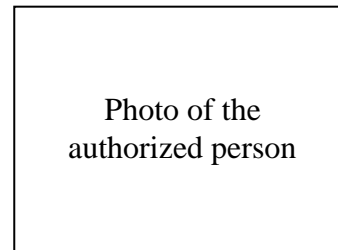
